Good Afternoon Jessie.

The title Director of Public Works has not changed since 2006, however the job responsibilities have steadily increased since then and in early 2017 the position assumed oversight over the Public Properties Department which included several additional divisions. The merging of the departments, doubled the size of the original Public Works Department therefore a stipend was allocated for the additional responsibilities. The City did not backfill the position of the Director of Public Properties and the City Council codified the organization of the new Public Works Department in the fall of 2017.

In addition, the recently vacated position of Assistant Director of Public Works and the Director of Public Properties were not backfilled leaving many of the responsibilities to be assumed by the Director of Public Works.

The added responsibilities are in addition to reducing the Engineering staff by nearly 30% in 2009.

Lastly, we do not anticipate the current Director of Public Works to be retiring anytime soon.
