Adam - my superintendent, Terry Snyder, forwarded me your email regarding public school district superintendent salaries in Wyoming.

For Fremont #25, Mr. Snyder did NOT receive a raise from \$157,218 (Superintendent Salary Schedule) to \$216,304. His contract <u>does</u> contain payment-in-kind payments that are paid out through payroll, but are NOT his salary.

Mr. Snyder's salary for 2016-2017 was \$157,218, for 2017-2018 remained \$157,218, and for 2018-2019 again remained \$157,218.

I cannot speak to the other districts and the "salaries" that were reported.
