LETTER FROM THOMAS W. SMITH & ADAM ANDRZEJEWSKI



In 1887, Alexander Fraser, a Scottish professor of history at the University of Edinburgh, had this to say about the Athenian Republic some 2,000 years prior.

A democracy is always temporary in nature; it simply cannot exist as a permanent form of government. Democracy will continue to exist until the time that voters discover that they can vote themselves generous gifts from the public treasury. From that moment on, the majority always votes for the candidates who promise the most benefits from the public treasury, with the result that every democracy will finally collapse due to loose fiscal policy, which is always followed by a dictatorship.

The average age of the world's greatest civilizations from the beginning of history has been about 200 years. During those 200 years, nations have always regressed to the following sequence:

- From bondage to spiritual faith
- From spiritual faith to great courage
- From great courage to liberty
- From liberty to abundance
- From abundance to selfishness
- From selfishness to complacency
- From complacency to apathy
- From apathy to dependence
- From dependence back to bondage

While history seems to be clearly repeating itself, New World technology gives us the ability to bring sunlight to how our tax dollars are being spent. Doing so will prolong the life of our great nation.

As the voting public becomes increasingly aware of how irresponsible spending dominates our government, as politicians begin to understand that, because of technology not available just a short time ago, there is no place to hide their fiscal irresponsibility, how we govern ourselves will change. Voters' expectations will change. Politicians will have no choice but to respond to voters' changed expectations.

Our focus at OpenTheBooks is to accelerate this government revolution by putting every government expense–local, state, and federal–online, available to the public real time via cell phone, iPad, and computer.

Last year, we filed 55,000 Freedom of Information Act requests. Our OpenTheBooks Government Expenditure Library, available to the public, now contains expenditures of \$19 trillion and is increasingly user-friendly. This was not possible just a short time ago. We can do this on a modest budget because of The Cloud and Big Data. In essence, we are ushering in a new era of government transparency.

Last year, our oversight reports led to four televised hearings in Congress. We had more media coverage than in the previous two years. Our website traffic grew 30%. We published 500 investigations. And as difficult as this was—we cracked open the California state checkbook for the first time in history! With the help of Judicial Watch, we filed four lawsuits against the secrecy culture that is so pervasive within the National Institutes of Health (NIH). As a result, we exposed \$325 million in previously hidden third-party royalty payments to Dr. Fauci and his associates since 2010.

Unfortunately, bureaucrats and politicians to a great extent, remain in the world of yesteryear. Secrecy continues to dominate. For example, the Vice President's office refuses to give us <u>ANY</u> information. The Federal Reserve has over 23,000 employees. They gave us only 369 salaries. We were told that their line-by-line vendor checkbook is simply not available. This with 23,000 employees?

Twenty years ago-after world wars, depressions, massive failed programs; i.e., the War on Poverty-the federal debt was slightly under \$6 trillion. In the last 20 years, the federal debt has exploded. It has increased over five times to more than \$31 trillion today with no end in sight. The political class, both Republicans and Democrats, based on actions, not words, shows no interest in attacking this exploding threat to our country.

Here are two examples of that "no end in sight" spending. Republican Congressmen, before they were sworn in, held a secret vote. A secret vote on earmarks! But not just on earmarks. A secret vote to develop a new procedure, a new name for earmarks to mask their fiscal irresponsibility from the voters. **One-hundred-and-fifty-eight Republicans voted for earmarks.** That secret vote tells you all you need to know about each Congressman's respect for his voters' tax dollars. Ask your Congressman if he voted in secret for earmarks.

Then there is the Senate. Just before the 2022 legislative session ended, **26 Republican Senators voted for a 4,176-page bill.** A \$1.7 trillion bill. A mislabeled, pork-filled bill. Do you think those Republican Senators read that bill? And this bill was endorsed by the Republican Senate leadership. Ask your Senator if he voted for this pork-filled bill.

If we are going to bring sanity to how our tax dollars are spent, it will not come from the top down. It has to start with the voters. That is what OpenTheBooks is all about.

By bringing the Washington secrecy culture public, by educating voters about how their money is being wasted, we believe politicians eventually will have no choice. They will have to think twice before, for example, choosing to participate in a secret meeting on how to spend their voters' tax dollars.

We greatly appreciate all of your help. Transparency has never been more important to the survival of our country as our founders envisioned it, as we have lived it.





OUR STRONGEST YEAR EVER

We published 500 oversight investigations in 2022, 200 more than we did in 2021. We filed 55,000 Freedom of Information Act (FOIA) requests up from 47,000 requests last year. We received 12,000+ media mentions and citations, which was more than in the previous two years combined!

We believe transparency revolutionizes how we govern ourselves.

Our mission is to expose the culture of corruption. We do this so you, the taxpayer, can follow the money – even in your school district, township, county, or municipality.

We publicized the \$7.2 billion taxpayer subsidy of Southwest Airlines. Our findings were cited on nearly every broadcast news station in the country!

In 2022, our reports were cited by The Wall Street Journal, Newsweek, Politico, The Washington Post, C-SPAN, Bloomberg Law, Axios, The Drudge Report, New York Post, Los Angeles Magazine, and many more. Hollywood star Russell Brand featured our third-party royalty findings across his platforms. I was interviewed live on television and radio 473 times - more than double the previous year.

Our oversight findings led to four hearings in Congress including the U.S. House appropriations hearing for the National Institutes of Health and three hearings with Dr. Anthony Fauci facing questions from our oversight.

Since January 2021, The National Institutes of Health had ignored our Freedom of Information Act request for the Fauci financials. In October 2021, with Judicial Watch as our lawyers, we sued NIH.

U.S. Senator Roger Marshall had Dr. Anthony Fauci under oath in the U.S. Senate hearing on January 11, 2022. Citing our investigations published at Forbes, Marshall asked Fauci to produce unredacted copies of his financial documents. Fauci misled Congress and the nation by saying that his finances were available and public knowledge. It wasn't true.

Right away, we wrote the piece at Forbes (45,000 views), "No, Fauci's Records Aren't Available Online. Why Won't NIH Immediately Release Them?" Our investigation was fact-checked by PolitiFact, who agreed with our analysis. Our organization had been suing NIH in federal court for the Fauci financials.

Immediately, we wrote the piece at Forbes quantifying Fauci's 2020 household income of \$1.7 million (177,000 views). It was the last piece our CEO ever wrote at Forbes. Fauci's Code Red Moment was the top news story nationally. In the U.S. Senate hearing, Dr. Fauci melted down on the hot mic and called Sen. Marshall a "moron."

Our coverage: Fox News Channel, Hannity!, Sinclair Broadcast News on nearly 200 ABC, NBC, CBS, and FOX affiliates across America, Newsmax, One America News, The Washington Post, The Wall Street Journal, New York Post, Daily Mail, and many others.

Sen. Roger Marshall introduced transparency legislation titled, The FAUCI Act, to open the books on all financial and conflict-of-interest disclosures required by law of federal bureaucrats.

Then, within 48 hours of the Senate hearing, Marshall received production. It was the first time that Fauci's 2019 and 2020 financials were publicly available.

For the first time in history, we cracked open the California state checkbook. We posted the line-byline payments to 201,684 state vendors who received nearly \$87.2 billion during fiscal year 2021.

It was a ten-year, knock-down-drag-out dog fight to open the books spanning two California state controllers. Then, in January 2020, we sued Controller Betty Yee in a Sacramento Superior Court after her office rejected our sunshine request for state spending. Yee claimed that she "couldn't locate" any of the nearly 50 million bills she paid in 2019.

California was the final holdout on state checkbook transparency. Forty nine of the 50 states, the U.S. federal government, and 15,000 municipalities produce their line-by-line spending in response to our request.

Incredibly, in a January 2022 ruling, Superior Court Judge Steven M. Gevercer agreed with another argument advanced by the controller - the California checkbook data was of limited public value and the burden on the controller to release even a single transaction outweighed the public interest. So, we got nothing.

Therefore, we shifted to plan B and filed **442 California Public Record Act requests** with each state agency. Most agencies complied and we assembled the state checkbook like a jigsaw puzzle.

We accomplished what the governor, controller, attorney general, lawmakers, a Superior Court judge, and state bureaucrats refused to do. Our auditors at OpenTheBooks.com found 979 state vendors who gave \$10,561,828 in political donations to Newsom during his 2010, 2018, recall election, and 2022 election cycles. Meanwhile, these companies reaped \$6,201,978,173 in state payments.

These donations represented the equivalent of more than 40-percent of the current cash on hand - \$24 million – in the governor's campaign committee

as of 08/01/2022, according to disclosures.

We <u>created an interactive map</u> displaying by ZIP Code all of the governor's campaign contributionsby name and employer, amount donated, when, and where located - across America.

We launched our investigation on our OpenTheBooks.Substack and it was quickly picked up in a digital story by FOX News in an article by Joe Schoffstall. Miranda Devine at the New York Post ran a full page article on our findings and cited us in her FOX & FRIENDS interview. Our full-page open letter in The Wall Street Journal highlighted Newsom. Sinclair Broadcast Group ran a digital story and aired our interview on The National Desk. Newsmax TV's morning program, Wake Up America, aired our interview as did The Dan Ball Show on One America News.

Our Sunday editorial ran in the Orange County Register and their 11 affiliated papers across Southern California. FOX26-Fresno aired our findings on broadcast news. The California Political Review, California Globe, AM870-LA - The Answer, Lars Larson National Radio, Bill Martinez National Radio, and others provided coverage.

Each year, the White House is mandated to release its annual report to Congress on the White House Office Personnel. The payroll data includes employee name, status, salary, and position title for all White House employees as of July 1, 2022.

The Biden White House spent \$100.7 million on the largest payroll in American history. No White House ever employed 500 staffers. Staff turnover was 39.3 percent: 560 employees (FY2021) and 474 (2022).

Biden employed 100 more staffers than Trump and five more than Obama at the same point in their respective presidencies.

The top-paid White House staffer was Francis Collins, the immediate past head of the National Institutes of Health. At the White House, Collins made \$300,000 in base salary during 2022.

Meet the Illinois \$100,000 Club. We found 43,000 educators in the public schools with six-figure salaries or retirement pensions. In Chicago, there are nearly 400 bus drivers making between \$100,000 and \$240,000. In small towns, city managers made up to \$341,300. Junior college presidents out-earned the U.S. President.

Our auditors created an interactive map of the six-figure club - mapping all 132,188 public employees by employer ZIP Code across the state. In 2019, there were 94,000 six-figure employees and 132,188 today.

Our earmark map was hyperlinked at Citizens Free Press and embedded at The National Desk by Sinclair Broadcast.


Within 36 hours, our investigation led to an immediate U.S. House Appropriations hearing with NIH Acting Director Lawrence Tabak answering questions from U.S. Rep. John Moolenaar (R-MI). South Dakota limits public employee salary disclosure to only one at a time. The state has roughly 8,000 employees.

The California controller refused to produce a single state expenditure. Not one transaction! We filed sunshine requests with each of the 442 state agencies and compiled state expenditures like a jigsaw puzzle.

The National Institutes of Health (NIH) refuses to answer our Freedom of Information Act requests. We sued NIH. We found over \$300 million in third-party royalty (pharmaceutical company) payments enriching NIH, its leaders, and over 2,000 of its scientists during the past ten years.

In 2022, the **Republican House held a secret vote on earmarks.** A SECRET vote on how they spend YOUR tax dollars. 158 Republican Congressmen voted to join Democrats to bring back earmarks.





Fauci's calendar has 933 events during this five-month period – including 224 media interviews and 84 redacted events – significant redactions that prevent understanding.

Prominent coverage: Newsweek published our editorial. Covid-hawks Steve Quayle, Alex Berenson, and Robert F. Kennedy wrote pieces highlighting our findings.

The Republican Study Committee will give it oversight.

Dr. Fauci was deposed using his official calendar by Missouri Attorney General Eric Schmitt as part of a lawsuit alleging government censorship during the pandemic (Biden v. Missouri).

Identified the "Bridge to No Where" in Alaska which helped to end the congressional practice of wasteful earmarks. Coburn's annual Waste Book was an oversight primer on federal taxpayer abuse. An entrepreneur with a career in obstetrics, Dr. Coburn delivered over 4,000 babies before the Senate passed a rule to stop his practice of medicine. Married to Miss Oklahoma (1967), Tom and Carolyn Coburn raised three girls.



PATRICK H. CADDELL, Board Advisor

Patrick H. Caddell was a political strategist, consultant and FOX news contributor.
