Dear Ms. Urbanek,

As a follow-up to the February 14, 2018 letter from Ms. Rebecca Zisch of the Wyoming Attorney General's Office on behalf of the State Auditor's Office and addressed to counsel for Equality State Taxpayers Association and American Transparency (openthebooks.com), below you will find record requests that meet the content discussed in our representatives' recent meeting with Ms. Zisch and as described in Ms. Zisch's February 14, 2018 letter:

### **Public Records Request #1**

Equality State Taxpayers Association and American Transparency (openthebooks.com) request an electronic copy of the cached information from the vendor payment website from January 1, 2013 to January 1, 2018.

### **Public Records Request #2**

Pursuant to the Public Records Act, Equality State Taxpayers and American Transparency (openthebooks.com) request a copy of the following records: the vendor list from January 1, 2013 through January 1, 2018. Production shall include an electronic copy of 'any' and 'all' vendor name; vendor address; vendor city; vendor state name; and vendor zip code. A 'vendor' is defined as 'a transfer of property or service recipient,' but does not include non-public information such as state employee addresses, payments under HIPPA, etc.

Regarding both Public Records Request #1 and #2: Your counsel has indicated that you would be providing an estimate of the time needed to comply with these requests. We look forward to hearing from you as quickly as possible on this. We further request to be present during the data collection to verify time incurred by the collection. If you wish we will provide the secure USB memory for the production of two copies of the data.

Since American Transparency is a public charity under IRS code 501(c)3 and this request is in the public interest, we respectfully request that **no fees** be assessed for the production of these very basic financial records. There is

no record more important in the State of Wyoming than where taxpayer money was spent by state government and who received said payments.
