Neither of these officers are currently employed by the Town. Detective Parent died suddenly in November of 2017. Lt. Prendergast retired abruptly in 2018 due to an injury. Neither of these officers' typical annual compensation reflect the figures you reference and these figures are likely skewed as they may reflect the payment of a one time death benefit to the family as well as all unused accrued time including compensatory time.

It should be noted that the town under the current administration negotiated a new contract that has cut the starting salaries and slashed the compensatory time accrual limit in half as well as other changes that are reducing costs and saving taxpayer dollars.
