Here is the City's response. As background, Tommy Gonzalez was appointed City Manager of El Paso, Texas, in June 2014. El Paso is the 20th largest city in the United States.

Comment from Laura Cruz Acosta, Strategic Communications Director for the City of El Paso: "Mr. Gonzalez, a retired Lieutenant Colonel, is a results-oriented, strategic leader with approximately three decades of management experience in the public sector. He oversees a budget of \$1 billion in operations and \$1 billion in capital expenditures; while leading more than 6,000 employees. By comparison area school district and county health leadership oversee budgets ranging from \$464 million to about \$600 million and report compensation packages ranging from \$360,000 to \$533,000.

Earlier this spring, Mr. Gonzalez led the City of El Paso Team in making history, by becoming the largest municipality in the nation to earn the Texas Award for Performance Excellence from the Texas Quality Foundation for the second year in a row. He also serves as a role model for leaders in municipal government, having been awarded the 2019 Baldrige Foundation Leadership Excellence Award in the Government sector by the Malcom Baldrige Foundation in Washington, D.C. Under his leadership, the City has been able to achieve \$90 million in cost savings, eliminated a \$7.8 million deficit, increased the City's fund balance by over \$20 million, maintained a double AA financial rating by improving accuracy in revenue and expenditure estimates, and lead a team that inherited 21 external audit findings and zeroed out those findings to zero for three years in a row. Additionally, under Mr. Gonzalez's tenure, the City has providing year-end reporting to the City Council, and five consecutive years of General Fund surplus."
