Hi Andrew,

As with previous practice, please run the following statement in full, attributable to me:

When Governor Brown travels on official state business, she may also engage in incidental non-state activities while traveling, which could include things like sightseeing, meeting a friend, or attending a campaign event. If participating in a campaign-related activity has an additional cost to the state, the campaign pays that cost.

Of the examples you gave: the February trip to Seattle incurred no additional cost; hotel costs for the Governor for the NGA trip were paid by the NGA; one night's hotel stay was covered by the campaign during the May Denver trip.

Here are three Oregon Ethics Commission opinions addressing similar situations.
