INTRODUCTION

On January 25, 2017, President Donald J. Trump <u>issued</u> Executive Order: Enhancing Public Safety in the Interior of the United States. The order denies federal funding to sanctuary cities who choose not to comply with federal laws regarding deportation of illegal entrants.

Reaction to the new policy from across the political spectrum was immediate. However, the politicians, pundits and journalists admitted that the total amount of federal funding was undetermined.


This report - **Federal Funding of America's Sanctuary Cites** - quantified federal funding (FY2016) to the agencies and entities of America's 106 Sanctuary Cities.

Conclusion: We sourced nearly \$27 billion to Sanctuary Cities in federal grants and direct payments.

BACKGROUND

DEFINITION OF SANCTUARY CITY

There is no definitive definition of a 'sanctuary city,' per se. However, the U.S. Department of Justice (DOJ) operationally **enforces** a legal definition. Under Federal Law 8 U.S.C. Section 1373, the DOJ defines sanctuary cities as a local government entity not reporting to federal authorities: 'aliens in custody.'



SCOPE

AMERICA'S SANCTUARY CITIES

According to a May 31, 2016 Department of Justice <u>memo</u> and studies from non-governmental organizations, there are nearly 300 government jurisdictions of states, counties, cities and other governments claiming status. Sources: Ohio Jobs and Justice PAC, <u>link</u>.

Our OpenTheBooks.com oversight report quantified only the cities. Therefore, the scope of our project narrowed to 106 American cities. A total population of 46.09 million, according to 2015 latest available U.S. Census data, lives within these sanctuary cities.

There are approximately 11 million illegal entrants residing within the United States. Twenty-percent of them live in just twelve American cities - 2.2 million of the total 11 million illegal entrant population.

Therefore, our report quantified the federal taxpayer dollars into all 106 sanctuary cities and breaks-out the twelves cities where 1 in 5 illegal entrants reside.

TOP 10 TAKEAWAYS FROM OUR REPORT

"Mayors defending their sanctuary city status by refusing to comply with federal law are essentially imposing a defiance tax on local residents. On average, this tax amounts to \$500 per man, woman and child. Major cities like Washington, D.C., New York and Chicago have the most to lose, and nearly \$27 billion is at stake across the country." – Adam Andrzejewski, CEO of OpenTheBooks.com

- 1. \$26.741 billion in annual federal grants and direct payments flowed into America's 106 sanctuary cities (FY2016).
- 2. On average, the cost of lost federal funding for a family of four residing in one of the 106 sanctuary cities is \$1,810 or \$454 per person. A total population of 46.2 million residents live in the 106 sanctuary cities according to census data.
- 3. Washington, D.C. and Chicago, Illinois residents received the highest amount of federal funding on a per capita basis and, therefore, have the most to lose by maintaining their sanctuary status.

Washington, D.C. municipal government received the highest amount of federal funding on a per capita basis: \$3,228 per person; \$12,912 per family of four; or \$2.09 billion total.

The City of Chicago, IL received the second highest amount of federal funding on a per capita basis: \$1,942 per person; \$7,768 per family of four; or \$5.3 billion total.

- 4. In cities with populations of 100,000 and above, the communities with the least per capita federal dollars 'at risk' are St. Paul, Minnesota (\$47 per person, \$14.2 million total); Downey, California (\$36 per person, \$4.2 million total) and Miami, Florida (\$67 per person, \$29.7 million total).
- 5. \$15.983 billion in federal funds flowed into just twelve major American cities where 1 in 5 illegal entrants reside (FY2016).
- **6.** Department of Justice grants to law enforcement i.e. city police departments totaled **\$543.97** million (FY2016). Typically, this funding was only a small percentage of the local law enforcement budgets.

- 7. \$4.23 billion in federal funding of the 106 sanctuary cities flowed via the 'direct payment' type. These payments funded municipal services such as housing, education, community development, and schools.
- **8. \$21.5** billion in federal funding of the **106** sanctuary cities flowed via the 'grant' payment mechanism. These payments funded local police and fire departments, schools, housing, and city services.
- **9.** In Los Angeles, fully 1 in 5 city residents (22-percent) are illegal entrants. However, the amount of federal funding amounts to only \$126 per resident; \$504 per family of four; or \$502.5 million total.
- **10.** In Newark, New Jersey, 19-percent of city residents are undocumented entrants. However, the amount of federal funding amounts to \$733 per resident; \$2,932 per family of four; or \$206.7 million.

New York City (population 8.55 million): the New York comptroller estimated federal payments of \$7.4 billion – not including \$1 billion in Hurricane Sandy and other disaster relief. Our OpenTheBooks.com analysis quantified \$7.645 billion of federal aid disclosed by the feds and paid to city agencies.

SAN FRANCISCO, CA TOTAL FEDERAL FUNDING: \$509.26 MILLION (FY2016) DIRECT FUNDING (\$237,281,236) | SUB-GRANTS (\$264,755,237)

San Francisco (population 837,400): \$480 million goes directly into the city coffers from the federal government <u>according</u> to the city comptroller. The comptroller disclosed another \$900 million in state specific funding. Our OpenTheBooks.com analysis shows \$509 million in federal grants and direct payments in San Francisco (FY2016).

- Direct and sub-grant funding of cities and their agencies of the 106 Sanctuary Cities sum to \$26.741 billion (FY2016).
- Department of Justice (DOJ) grants to law enforcement i.e. city police departments: \$543.97 million (FY2016).
